The Procurement Professional of the Year award recognises an individual who works within the procurement department of a Supply Nation member organisation and has driven significant growth in sustainable supplier diversity through their organisation's supply chain.

The winner will have demonstrated success in:

- Supplier diversity leadership and advocacy within their organisation and the wider sector
- Demonstrated growth in procurement spend with Supply Nation Indigenous businesses in 2020 and 2021 (will be verified against SpendTracker data)
- Demonstrated supplier diversity growth over the 2020-2021 calendar years
- Demonstrated success in implementing sustainable approaches that drive supplier diversity in the organisation's supply chain
- Demonstrated commitment to building a prosperous, vibrant and sustainable Indigenous business sector

Context Questions

Note: context questions are not judged but provide the judging panel with context about you/your organisation.

- 3. Job title of the nominee and department this role sits within (e.g. Procurement)
- 4. How long have you/the nominee been in the current role?

- 5. Briefly describe any past relevant positions which demonstrate procurement experience. **200 words** max.
- 6. 2021 has been a tumultuous year with COVID-19 impacting businesses around the globe. Please outline how your business has been impacted by the pandemic either positively or negatively. This may include aspects such as revenue/cashflow/spend or engagement with Indigenous businesses/special projects or new initiatives. 300 words max.

- 1. How does the nominee incorporate or champion supplier diversity within their role? 250 words max.
- 2. What influence has the nominee had on the growth of supplier diversity in your organisation and / or the wider sector? **350 words max.** Hint: Explain how the nominee's influence has resulted in year-on-year growth.
- 3. How many Supply Nation Indigenous businesses did you do business with in 2021?
- 4. How many Supply Nation Indigenous businesses did you do business with in 2020?
- 5. What is the percentage increase in the number of Supply Nation Indigenous businesses that you did business with over the 2020-2021 calendar years?
- 6. What was the value of contracts you had with Supply Nation Indigenous businesses in the 2021 calendar year?
- 7. What is the value of contracts you had with Supply Nation Indigenous businesses in the 2020 calendar year?
- 8. What is the percentage increase in the value of your contracts with Supply Nation Indigenous businesses over the 2020-2021 calendar years?
- 9. What percentage of your overall organisational procurement spend was with Supply Nation Indigenous businesses in 2021?
- 10. What percentage of your overall organisational procurement spend was with Supply Nation Indigenous businesses in 2020?
- 11. What were the main factors that influenced any change in spend with Supply Nation Indigenous businesses from 2020 to 2021? **350 words max.**
- 12. What policies / procedures and / or strategies has the nominee developed and implemented to drive sustainable supplier diversity within your organisation? **350 words max.**
- 13. What are the impacts that you have seen in the business as a result of the above? 350 words max
- 14. Explain other ways the nominee demonstrates their commitment to the Indigenous business sector.

- 15. Give examples of supplier diversity advocacy above and beyond the nominee's core role. **350 words** max.
