



## Registered Supplier of the Year 2026

This document lists the questions and word limits to assist you in preparing the submission prior to completing it online. You will also be required to upload company logos, photos and / or documents. You may start the online nomination at any time and update or amend it prior to **11:59pm AEDT, Sunday 22 March 2026**.

**Submissions will not be accepted via any other method.**

Note: if an individual or organisation won an award in 2024 or 2025, they are **not** eligible to be nominated for the same category in 2026.

### Category Description and Criteria

This award recognises a Registered Supplier (including sole traders) listed on Indigenous Business Direct that has driven significant growth in their business and has demonstrated ongoing engagement with Supply Nation and / or our members.

#### The winner will have:

- An active and well-articulated strategy to sustainably embed their business in the supply chains of Supply Nation members and / or Indigenous suppliers.
- Demonstrated increased business engagements with Supply Nation members and / or Indigenous suppliers.
- Demonstrated activity in building and promoting long-term relationships with fellow Supply Nation Indigenous suppliers, Supply Nation members and / or advocates of supplier diversity.
- Demonstrated business growth e.g. increased revenue / employment.
- Demonstrated commitment to building a prosperous, vibrant and sustainable Indigenous business sector.

## Context Questions

Please note: these questions are not scored by our judging panel but do provide them with valuable context about the nominee.

1. Tell us about the nominee. (Describe the business you are nominating, what it does, its key goals or objectives, and / or vision or values) **100 words max.**
2. When did the nominee become registered with Supply Nation? (Please provide the month and year)
3. Tell us about the nominee's journey, vision and inspiration. (Why was the business created? What are the business's values?) **100 words max.**

## Criteria Questions

Please note: these questions are scored by our judging panel and have been developed to align with the category criteria as set out on the first page.

1. What strategies, plans or processes does the nominee have in place to actively market their services to Supply Nation members and / or Indigenous suppliers? **150 words max.**
2. What percentage of the revenue does the nominee spend on marketing?
3. List three strategies the nominee uses to maximise opportunities for repeat / referral business? **75 words max.**
4. What percentage of the contracts / engagements / sales are repeat or referral business?
5. List two major risks facing the nominee's business and what strategies are in place to mitigate these risks? (E.g. economic / social / competition / sector / industry) **200 words max.**
6. How many Supply Nation members and / or Indigenous suppliers did the nominee collaborate with in 2025?
7. How many Supply Nation members and / or Indigenous suppliers did the nominee collaborate with in 2024?
8. What is the percentage increase in the number of Supply Nation members and / or Indigenous suppliers the nominee collaborated with between the 2024 – 2025 calendar years?
9. What is the percentage increase in the value of contracts with Supply Nation members and / or suppliers between the 2024 – 2025 calendar years?
10. What was the percentage increase in revenue between the 2024 – 2025 calendar years?
11. What was the percentage increase in employment between the 2024 – 2025 calendar years?
12. What percentage of the workforce is made up of Aboriginal and / or Torres Strait Islander people?
13. Explain other ways the nominee positively impacts the Indigenous business sector. **150 words max.**

As part of this nomination, you must attach the files listed below. The maximum size is 5MB per file. The content you choose to upload will be used if you are selected as a finalist in the award category.

1. Between one and four photos of the nominee and / or their team (high-resolution, at least 1MB and portrait orientation NOT landscape).
2. High-resolution business logos:
  - Full colour and black and white versions
  - Horizontal and vertical / stacked options
  - Preferred file type: vector (.ai or .eps), also accepted: .png, .jpg
